## WAIVER OF RELEASE AND LIABILITY

I, in agreement with my spouse, in consideration of the risk of injury while participating in teaching at Seminario Reformado Latinoamericano (SRL) or any other Activity related to SRL, scheduled for any time or place of my participation, and as consideration for the right to participate in the Activity, hereby, for myself, my heirs, executors, administrators, assigns, or personal representatives, knowingly and voluntarily enter into this waiver and release of liability and therefore waive any and all rights, claims, or causes of action of any kind whatsoever arising out of my participation in the Activity, do hereby release and forever discharge SRL, its affiliates, managers, members, agents, attorneys, staff, volunteers, heirs, representatives, predecessors, successors and assigns, for any physical or psychological injury, including, but not limited to, illness, paralysis, death, damages, and economic or emotional loss that I may suffer as a direct result of my participation in the aforementioned Activity, including travel to and from the event related to this Activity.

I am voluntarily participating in the aforementioned Activity and am participating in the Activity entirely at my own risk. I am aware of the risks associated with traveling to and from, as well as participating in, this Activity, which may include, but are not limited to, physical or psychological injury, kidnapping, pain, suffering, illness, disfigurement, temporary or permanent disability (including paralysis), economic or emotional loss, and death. I understand that these injuries or outcomes may arise from my own or others' negligence, conditions related to travel or the condition of the Activity location(s). Nonetheless, I assume all related risk, both known and unknown to me, for my participation in the Activity, including travel to, from, and during this Activity.

I agree to indemnify and hold harmless SRL against any and all claims, suits or actions of any kind whatsoever for liability, damages, compensation or otherwise brought by me or anyone on my behalf, including attorney's fees and any related cost, if litigation arises pursuant to any claims made by me or by anyone else acting on my behalf. If SRL incurs any of these types of expenses, I agree to reimburse SRL.

I acknowledge that SRL, its directors, officers, volunteers, representatives and agents are not responsible for errors, omissions, acts or failures to act on any part or entity conducting a specific event or activity on behalf of SRL.

I acknowledge that I have carefully read this Waiver and Release form and fully understand that it is a release of liability. I expressly agree to release and discharge SRL and all of its affiliates, managers, members, agents, attorneys, staff, volunteers, heirs, representatives, predecessors, successors and assigns, from any and all claims of causes of action and I agree to voluntarily give up or waive any right that I otherwise have to bring a legal action against SRL for personal injury or property damage.

In the event that I should require medical care or treatment, I agree to be financially responsible for any cost incurred as a result of such treatment. I am aware and understand that I should carry my own health insurance.
